Drink only tap water, suggests Croatia

ZAGREB (CROATIA): Authorities in Croatia on Wednesday recommended people drink only tap water as they investigated reports of several cases of people getting sick and suffering injuries allegedly after consuming bottled beverages. Health Minister Vili Beros said several people have sought medical help for "injuries inflicted by suspected chemical elements." Most have had mild symptoms and will be released home, he said. Health authorities ordered the "suspected" products pulled out from shops, restaurants and elsewhere. They did not say which products were being withdrawn, but photos on social media from shops suggested they were Coca-Cola brands.

As using weapons left by US: Pak PM

ISLAMABAD: A day after the US said that it has not left behind any weapons during its withdrawal from Afghanistan, Pakistan's caretaker Prime Minister Anwaar-Ul-Haq Kakar on Wednesday said terrorists were using American-made arms against his country. Highlighting that American-made weapons are being sold in the black market not just in Pakistan but also throughout the region as well as the Gulf countries, Kakar emphasised that Islamabad was standing firm on its stance regarding United States' weapons being used for terrorism in Pakistan, Geo News said in a report.

Citigroup bank fined \$25.9 mn

NEW YORK: Citigroup intentionally discriminated against Armenian Americans when they applied for credit cards, the Consumer Financial Protection Bureau said on Wednesday, as the bank argued internally that Armenians were more likely to commit fraud and referred to applicants as "bad guys" or affiliated with organised crime. The CFPB found that Citi employees were trained to avoid approving applications with last names ending in "yan" or "ian" - the most common suffix to Armenian last names - as well as applications that originated in Glendale, California, where roughly 15 per cent of the country's Armenian American population lives.

Putin for closer Russia-China ties on prospective weapons

AP / Moscow

Russian President Vladimir Putin told a senior Chinese military official on Wednesday that Moscow and Beijing should expand their cooperation on military satellites and other prospective defence technologies - a statement that signalled increasingly close defence links between the allies.



Putin spoke in televised remarks at the start of his meeting with Gen Zhang Youxia, who is China's second-ranking military official and vice chairman of the Central Military Commission. The Russian leader emphasised the importance of developing closer military links, noting that cooperation in high-tech spheres now takes priority.

"I mean space, including high-orbit assets, and new prospective types of weapons that will ensure strategic security of both Russia and the People's Republic of China," Putin said without elaboration.

He emphasised that while "Russia and China aren't building any military alliances based on Cold War patterns," their cooperation is a "serious factor in stabilizing the international situation". Beijing declared last year that it had a "no-limits" friendship with Russia. China has denounced Western sanctions against Moscow, and accused NATO and the United States of provoking Russia's military action in Ukraine even as it tried to project itself as neutral in the Ukrainian conflict.

G7 CALLS FOR HUMANITARIAN PAUSE IN ISRAEL-HAMAS WAR

AP / Tokyo

Top diplomats from the Group of Seven leading industrial democracies announced a unified stance on the Israel-Hamas war on Wednesday after intensive meetings in Tokyo, condemning Hamas, supporting Israel's right to self-defence and calling for "humanitarian pauses" to speed aid to desperate civilians in the Gaza Strip.

In a statement following two days of talks, the nations sought to balance unequivocal criticism of Hamas' attacks against Israel and "the need for urgent action" to help civilians in the besieged Palestinian enclave.

"All parties must allow unimpeded humanitarian support for civilians, including food, water, medical care, fuel and shelter, and access for humanitarian workers," said the statement, hammered out by US Secretary of State Antony Blinken and foreign ministers from Britain, Canada, France, Ger-


"Mothers and sisters, for your respect I will do whatever I can," he asserted.

## CONG: NOTE BAN ENDED ECO RECOVERY

NEW DELHI: The Congress on Wednesday attacked the Modi government on the seventh anniversary of demonetisation, saying the "reckless" decision broke the back of the Indian economy and the country will not forgive the prime minister for this "monumental disaster".

Congress chief Mallikarjun Kharge said demonetisation was the "biggest assault on the economy and livelihood", while party leader Rahul Gandhi said the move was a "well thought-out conspiracy" to pick pockets of common men and fill the coffers of "friends" and make them rich. He questioned why ₹2,000 notes were even introduced.

Party leader Jairam Ramesh said note ban along with a "badly designed" GST finished off India's job-generating small and medium businesses, caused a 45-year unemployment high, and ended the economic recovery that had begun in 2013. "Who can forget the PM mocking people's suffering, laughing and saying *ghar mein shadi hai, paisa nahi hai*? Who can forget the hundreds of poor and middle-class people who died waiting in long lines to convert their notes, even as the wealthy managed to exchange their banknotes with ease," he said, adding, the exercise failed to achieve any of its stated objectives.

# Priyanka attacks PM on 'nothing done in 70 years'

Urges people not to vote on religious lines

Congress leader Priyanka Gandhi on Wednesday ridiculed Prime Minister Narendra Modi for his claim that nothing happened in India for 70 years until he came to power in 2014.

Speaking at Sanwer in Madhya Pradesh, she said, "If nothing happened in 70 years, then how did Modi go to school? If you go to school, it must have been built by Congress. I don't know whether Modiji went to a college or not!"

But his 'entire Political Science' certificate must have been printed on the computer given by Congress, she said.

Priyanka said if Congress did nothing in 70 years, then who created IIT, IIM and AIIMS. "The airports, ports which you are handing over to Adani, Modiji is handing over big companies to his friends at throwaway prices. Who made all this?" she asked.

"Modiji, what did you do in 10 years - why doesn't he tell you? What did you do in Madhya Pradesh in 18 years?" Priyanka asked.

Addressing a public meeting for Congress candidate Deepak Joshi in Khategaron of Dewas, Priyanka targeted the BJP saying the issue of religion is raked up during the elections, and urged people to avoid giving their votes on religious lines.

"People say that Madhya Pradesh is a laboratory of the RSS. Whenever elections come, the issue of religion is raked up. Everybody's feelings are associated with reli-

gion irrespective of one's faiths. Will you not open your eyes when religion is being used and votes are sought?" she asked the gathering.

"The biggest political objective is that you (people) should be served, there should be progress, the country should be strong," she said.

But people are being made to fight among themselves on religious lines for the sake of politics, she alleged.

Instead of voting on religious lines, people should seek the account of work

from the leaders, she added. "The government brought the Agnipath scheme, which provides temporary jobs in the army, for the sons of farmers who serve the country. But they (those in power) make arrangements for their own sons to study in foreign countries, also arrange costly vehicles and palaces for them," she said.

The Congress governments in Karnataka, Rajasthan, Himachal Pradesh and Chhattisgarh have fulfilled various promises made to farmers, women and youth, she said. "But the BJP government in Madhya Pradesh, on the contrary, implemented schemes like Ladli Behna when elections came near. Where was the government in the last 18 years?" she asked.

She also targeted the BJP government at the Centre and Madhya Pradesh, accusing it of failing to rein in inflation.

"Why are the government posts lying vacant in Madhya Pradesh despite the BJP being in power for the last 18 years?" she asked.

## SANATANA DHARMA CONTROVERSY

# 'Stalin Jr's beliefs based on Periyar, Ambedkar writings'

Tamil Nadu Sports Minister Udhayanidhi Stalin had made remarks about Sanatana Dharma based on his understanding of the speeches and writings of Dravidian movement leaders Periyar EV Ramasamy and Father of the Constitution BR Ambedkar, the Madras High Court was informed on Wednesday.

Justice Anita Sumanth, who is hearing a writ of quo warranto against Udhayanidhi, during the hearing asked the counsel on the basis of which literature he understood that Sanatana Dharma promoted caste system. "Your understanding appears to be that it refers to varnas or the inherent divisions on the basis of caste... What is the research that was done to arrive at such an assumption," she asked.

DMK Rajya Sabha member and Udhayanidhi's senior counsel P Wilson said it was

based on speeches and writings of Periyar and Ambedkar. He pointed out the petitioner, who had questioned under what authority Udhayanidhi was continuing as a minister, has relied on a 1902 edition of *Sanatana Dharma - An Advanced Textbook of Hindu Religion and Ethics* published by the Board of Trustees of Central Hindu College in Banaras (now Varanasi). The book states it is based upon four Smritis, including the Manusmriti, which propagates Varnas or division on the basis of caste assigned by birth.

To a specific question from the judge, the senior counsel said Udhayanidhi had access to this book even before delivering his speech at the conference to eradicate Sanatana Dharma as it was in the public domain. Wilson also submitted that Ambedkar had burnt copies of the Manusmriti.

The judge thereafter adjourned the hearing.

# WILL TRADE IN NATIONAL CURRENCIES: MALAYSIA

Says Kuala Lumpur looking at accepting RuPay, UPI service

India and Malaysia are firming up a framework for conducting trade in national currencies and initiating a process to review the 12-year-old comprehensive economic cooperation agreement to include new domains and items, Malaysian Foreign Minister Zambry Abdul Kadir said.

At the end of a three-day visit to India, Kadir said Malaysia is also in the process of accepting India's Unified Payments Interface (UPI) system and RuPay payment service that will boost overall financial engagement.

The Malaysian foreign minister said Prime Minister Anwar Ibrahim is likely to visit India in the first half of next year in reflection of growing upswing in overall ties between the two nations.

He said both sides are keen to expand trade engagement in new and emerging areas such as electronics, semiconductors, fintech, renewable energy, new technology and startups besides joining hands in de-



Kadir expressed gratitude to India for providing 170,000 MT of non-basmati white rice recently when the country was reeling under shortage of rice

fence industrial cooperation. About India's long-pending demand to Malaysia to extradite fugitive evangelist Zakir Naik, Kadir did not give a direct reply and said Kuala Lumpur is keen on strengthening institutional mechanisms to boost security cooperation rather than focusing on any individual.

On escalating tensions in South China Sea in view of China's increasing assertiveness, Kadir said Malaysia and other member nations of the ASEAN do not want to allow this region to become a "flashpoint" and an area for "big power" competition.

He said Malaysia, India and other like-minded countries must contribute towards ending the Israel-Hamas conflict as the unfolding "humanitarian calamity" in Gaza is a matter of great concern. He called for an immediate cessation of hostilities saying it is absolutely vital to stop further loss of lives and for carrying out delivery of humanitarian aid to Gazans.

# BJP calls tribals vanvasi, asks them to shun Eng: Rahul

Says it doesn't want them to dream big

Congress leader Rahul Gandhi on Wednesday said the BJP calls the tribals *vanvasi* instead of *adivasi* as it does not want them to "dream big".

At a rally in Surguja's Ambikapur ahead of the second phase of the assembly poll in Chhattisgarh, he hit out at BJP leaders for asking the tribals not to learn English while sending

their own kids to English-medium schools.

"BJP used the term *vanvasi* (forest-dwellers) for *adivasis*. There is a huge difference between *vanvasi* and *adivasi*. You must have seen

the video where a BJP leader urinated on a tribal man," the Congress leader said, referring to an incident in the BJP-ruled Madhya Pradesh.

That incident reflected the BJP's mindset, he alleged.

"The term *adivasi* (original inhabitant) has a deep meaning. It expresses your rights to *jal, jungle, zameen* (water, forest, land), *Vanvasi* means those who live in the jungle. The BJP calls you *vanvasi*, we call you *adivasi*. The BJP snatches your rights, we give you rights. We hug you, BJP leaders urinate on you." Forest cover in the country is shrinking and when it disappears in 15-20 years, where would the *vanvasi* go, would they beg on the streets, the Gandhi dynast asked.

The electoral battleground in Rajasthan is set to witness keen contests among not just arch-rivals but close relatives like man and wife, brother- and sister-in-law and uncle and niece pitted against each other by political parties. Five seats have close relatives as opponents, proving that in politics and fight for power, relations take a back seat.

The most-interesting contest is in the Danta Ramgarh assembly seat in Sikar district. The Congress has fielded Virendra Singh while his wife Rita Singh has been given a ticket by Ajay Chautala's Janmayak Janata Party. The couple separated in 2018. Rita Singh has been the zila pramukh and was a contender for the Congress ticket, which chose her husband Virendra Singh, the sitting MLA.

have switched loyalties. Congress candidate Shobha Rani Kushwaha was the BJP candidate from Dholpur in 2018. BJP leader Shivcharan Kushwaha was the Congress candidate.

The candidates of the Congress and the BJP in the Sojat assembly segment in Pali share the same relationship. Congress leader Niranjana Arya is a former Rajasthan chief secretary, whereas the BJP has fielded sitting MLA Shobha Chouhan.

In two constituencies, uncles are taking on nieces from the Khetri assembly seat in Jhunjhunu's Neem Ka Thana, and the Nagaur assembly constituency in Bharatpur.

In Khetri, Dharampal Gurjar, his brother Dataram Gurjar and Dataram's daughter Manisha Gurjar were seeking a ticket from the BJP. The party is with Dharampal. Angered over the denial of the ticket, Manisha raised a banner of revolt against the saffron camp. The Congress accepted her and gave her a ticket. Dharampal and Manisha have a direct fight in the Khetri constituency.



Ditto in the Nagaur assembly seat where the Congress has fielded **Harendra Mirdha** while the BJP candidate is **Jyoti Mirdha**, who was the Congress MP from Nagaur in 2009, and was the party candidate in 2014 and 2019. She joined the BJP recently and Harendra is her uncle.
