In terms of applicable circulars issued by Ministry of Corporate Affairs (MCA) from time to time including latest General Circular No. 03/2025 dated 22nd September, 2025 ("MCA Circulars") and Securities and Exchange Board of India ("SEBI") vide its Master Circular No. HO/49/14/14(7)2025-CFD-POD2/I/3762/2026 dated January, 30, 2026 ("SEBI Circulars"), have permitted companies to conduct AGM through Video Conferencing (VC) or other audio-visual means (OAVM), subject to compliance of various conditions mentioned therein. 2. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of ascertaining the quorum under Section 103 of the Companies Act, 2013 (the Act).

3. **Electronic Dispatch of Notice and Annual Report:** In compliance with the aforesaid MCA and SEBI circulars physical copies of the financial statements (including Board's Report, Auditor's Report or other documents required to be attached therewith) for the Financial Year ended 31st March, 2026 pursuant to Section 136 of the Act and Notice calling the AGM pursuant to Section 101 of the Act read with the Rules framed thereunder are being sent only in electronic mode to those Members whose e-mail addresses are registered with the Company/Registrar and Share Transfer Agent or the Depositories. The Company will not be dispatching physical copies of such statements and Notice of AGM to any Member. A Member can request for a physical copy of the Report by sending an e-mail to the Company at oswalgroups2002@gmail.com. Further as per amended Regulation 36 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, a letter which providing the weblink including the exact path, where complete details of Annual Report are available, will be sent by the Registrar and Share Transfer of the Company to those shareholders who have not registered their email address(es), at their address registered with the Company.

4. Since the 9th AGM of the Company will be convened through VC/ OAVM, where there will be no physical attendance of members, the requirement of appointment of proxies pursuant to the provisions of Section 105 of the Act has been dispensed with. Accordingly, route map, attendance slip and proxy form will not be annexed to this Notice.

6. Pursuant to the provisions of Sections 112 and 113 of the Act, Corporate/ Institutional member can authorize their representatives to attend the AGM through VC/OAVM and cast their votes through e-voting. As per the provisions of Clause 3.A.II of the General Circular No. 20/ 2020 dated May 5, 2020, the matters of Special Businesses as appearing at Item Nos. 3 to 6 of the accompanying Notice, are considered to be unavoidable by the Board and hence forming part of this Notice.

8. In terms of the Article of Association of the Company read with Section 152(6) of the Companies Act 2013, Mrs. Padma Nahata (DIN: 07921042) is liable to retire by rotation at the ensuing Annual General Meeting and being eligible offer herself for re-appointment. The Board of the Directors of the Company recommends her re-appointment.

9. Further, Company earned net profit after tax before other comprehensive income of INR **294.13** Lakhs as against previous year in which Company earned net profit after tax before other comprehensive income of INR **284.86** Lakhs.

- On a consolidated basis, your Company has revenue from operation of INR 24822.92 Lakhs for the financial year ended 31st March, 2026 as against INR 24591.28 Lakhs in the previous year. Further, company earned consolidated net profit after tax before other comprehensive income of INR 722.26 Lakhs as against previous financial year in which company incurred consolidated net loss after tax before other comprehensive income of INR 352.89 Lakhs.

The Consolidated financials reflect the cumulative performances of Shreeoswal Seeds and Chemicals Limited along with its wholly owned material subsidiary Company Shreeoswal Psyllium Exports India Limited. Detailed description about the business carried out is contained in the Management Discussion and Analysis report.

3. Regular maintenance and servicing of processing machinery, equipment and electrical installations to ensure optimum operating efficiency and minimize energy consumption.
4. Optimization of the use of processing, grading, cleaning, drying, packaging and other equipment to improve operational efficiency and reduce avoidable energy consumption.
5. Continuous monitoring of energy consumption and implementation of energy conservation measures wherever technically and commercially feasible.

b. The steps taken by the company for utilizing alternate sources of energy:-

The Company continues to evaluate the feasibility of utilizing renewable and alternate sources of energy in its operations. During the year under review, the Company used Diesel Generator (DG) sets as a standby source of power during power interruptions to ensure continuity of its seed processing and other operations.

c. The capital investment on energy conservation equipment:- NIL

(ii) **Technology Absorption:**

a. The effort made towards technology absorption-

The Company has adopted and utilized modern seed processing and handling technologies and equipment for cleaning, grading, drying, treatment, processing, packaging and storage of agricultural seeds, including maize and soybean seeds. The Company continues to undertake measures for modernization and technological improvement of its processing facilities with a view to enhancing productivity, operational efficiency and quality of seeds.

b. The benefits derived like product improvement, cost reduction, product development or import substitution: The use of modern processing technologies and equipment has contributed towards improvement in seed processing efficiency, product quality, productivity, grading and handling, reduction in processing losses and optimization of energy consumption.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

1. INDUSTRY STRUCTURE AND DEVELOPMENT

The global seed industry forms an integral part of the agricultural value chain and plays a critical role in supporting food security, agricultural productivity and sustainable farming. The industry continues to evolve on account of advancements in plant breeding, biotechnology, hybridisation, seed treatment technologies, climate-resilient varieties, precision agriculture and digital farming solutions.

The long-term demand for quality seeds remains supported by population growth, increasing food consumption, limited availability of arable land, changing climatic conditions and the need to improve agricultural productivity. The increasing adoption of hybrid and improved varieties is also contributing to the development of the organised seed industry.

India continues to be one of the important agricultural markets globally, with the seed industry benefiting from increasing awareness among farmers regarding the advantages of quality seeds, improvement in seed replacement rates, expansion of irrigation facilities, increasing mechanisation and adoption of scientific farming practices.

The Indian agricultural sector remained resilient during FY 2025-26. As per the First Advance Estimates released by the Ministry of Agriculture & Farmers Welfare, Kharif foodgrain production for 2025-26 was estimated at approximately 1,733.30 lakh metric tonnes, higher than the corresponding estimate for the previous year. Rice and maize also recorded encouraging production estimates, reflecting the resilience of Indian agriculture.

The Government continues to support the agricultural sector through various initiatives relating to agricultural modernisation, irrigation, crop insurance, digital agriculture, farmer welfare, rural infrastructure and productivity enhancement. Such initiatives, together with increasing private-sector participation in research and development, are expected to support the long-term development of the Indian seed industry.

The Company's principal business is seasonal agricultural seeds and the Company caters to the requirements of farmers across various crop segments and geographical markets. Demand for the Company's products is influenced by agricultural acreage, monsoon and weather conditions, irrigation availability, cropping patterns, commodity prices and farmer purchasing behaviour.

The Company continues to focus on quality improvement, strengthening its distribution network, increasing farmer outreach, expanding its geographical presence and developing products suited to diverse agro-climatic conditions. The Company believes that the long-term prospects of the seed industry remain positive, supported by the growing need for higher agricultural productivity and efficient utilisation of available agricultural resources.

2. OPPORTUNITIES AND OUTLOOK

The Indian agricultural sector continues to present substantial opportunities for growth, creating a favorable environment for the seed industry. Rising population levels, increasing food consumption, shrinking cultivable land availability, and growing pressure on agricultural productivity are expected to drive long-term demand for quality seeds.

By 2050, the world will have 10 billion people, with Indian accounting for 1.73 billion (Source: United Nations). To feed India's growing population, the yield per hectare needs to increase

significantly, especially keeping in mind the declining arable land in India. Further, India's agricultural yield is far lower as compared to global averages. Extreme weather coupled with low penetration of high-yielding hybrid seeds, lack of awareness of modern agricultural technologies and inefficient use of agrochemicals are some of the factors behind the low yield. This presents a significant opportunity for the Company's Crop Protection and Hybrid Seeds business along with opportunities for expanding crop advisory and digital offerings.

Innovations in seeds, crop protection and digital farming solutions can go long way in addressing the productivity problems affecting Indian agriculture. It will also help farmers get good commodity prices, encouraging them to spend on qualitative inputs for achieving higher yields.

Seed is the first and best hope a farmer has and forms the foundation of "Socio-Economic Empowerment and Development." Over the last decade, the Indian seed industry has grown significantly, driven by both private and public sector participation. Valued at \$6.3 billion in 2022, the market is projected to reach \$16.5 billion by 2030, expanding at a compound annual growth rate (CAGR) of approximately 12.4%.

Farmers are increasingly recognizing the economic benefits of certified and improved seed varieties. Higher germination rates, better crop stand establishment, disease resistance,

improved yield potential, and enhanced profitability continue to encourage seed replacement and adoption of quality seeds.

Expansion of Irrigation Infrastructure

Government investment in irrigation projects, micro-irrigation systems, watershed development programs, and rural infrastructure is expected to reduce dependence on monsoon rainfall and improve agricultural productivity. Enhanced irrigation coverage creates greater demand for quality seed varieties capable of maximizing crop output.

Government Support for Agriculture

The Government of India continues to prioritize agricultural development through various initiatives aimed at increasing farm income, improving productivity, promoting sustainable agriculture, and strengthening food security. Programs relating to crop insurance, agricultural credit, digital agriculture, farmer welfare, and rural development are expected to support long-term growth in seed demand.

Technological Advancements

Advancements in plant breeding, seed treatment technologies, biotechnology, digital farming Solutions, weather forecasting tools, and precision agriculture are creating opportunities for Seed companies to develop superior products that meet evolving farmer requirements.

Growing Demand for Climate-Resilient Varieties

Changing climatic conditions have increased demand for drought-tolerant, disease-resistant, heat-tolerant, and stress-resistant crop varieties. Companies capable of developing such varieties are expected to benefit from increasing market acceptance.

Distribution Network Expansion

The Company continues to strengthen its dealer network, distributor relationships, and farmer outreach programs. Expansion into new geographical markets provides opportunities for increasing market penetration and enhancing brand recognition.

Research and Product Development

The Company remains focused on introducing improved seed varieties tailored to regional agricultural requirements. Continuous investment in product development and quality enhancement is expected to strengthen competitive positioning and support sustainable growth.

Considering these favorable industry dynamics, the long-term outlook for the Company's seed business remains positive. The Company is well-positioned to benefit from increasing demand for quality seeds and evolving agricultural practices across India.

3. THREATS

Despite favorable long-term prospects, the seed industry remains exposed to various external and internal risks that may influence business performance.

Climatic and Weather Risks

Since agricultural production is heavily dependent upon climatic conditions, adverse weather events such as delayed monsoons, deficient rainfall, droughts, floods, hailstorms, cyclones, heat waves, and unseasonal rainfall can significantly affect sowing activities and seed demand.

Agricultural Commodity Price Volatility

Farmers' purchasing decisions are directly influenced by prevailing crop prices. Significant fluctuations in commodity prices may alter cropping patterns and reduce investment in quality seeds.

Competitive Intensity

The seed industry is highly competitive with participation from multinational corporations, established domestic companies, regional players, and unorganized sector participants. Intense competition may result in pricing pressures and margin challenges.

Regulatory Changes

The industry is subject to various regulations governing seed certification, quality standards, labeling requirements, intellectual property rights, environmental regulations, and agricultural policies. Changes in regulatory frameworks may affect business operations and compliance costs.

Pest and Disease Outbreaks

Large-scale pest infestations, crop diseases, and biological threats can adversely impact crop cultivation and influence demand patterns for specific seed varieties.

Input Cost Inflation

Increases in procurement, processing, packaging, logistics, labour, energy and other operating costs may affect margins if such increases cannot be adequately absorbed or passed on to customers.

Supply Chain Disruptions

Any disruption in procurement, transportation, storage, processing, or distribution activities may impact operational efficiency and customer service levels.

Performance of the Seeds segment during the year was influenced by factors such as monsoon conditions, crop acreage, and farmer purchasing behavior, agricultural commodity prices, and regional demand patterns. The Company continued to focus on quality enhancement, market penetration, distribution network strengthening, and customer engagement initiatives.

Psyllium Segment

The Psyllium segment contributes additional revenue streams and enhances diversification of the Company's business portfolio. Demand in this segment is influenced by domestic consumption trends, export opportunities, agricultural production levels, and market conditions.

The presence of multiple business segments enables the Company to diversify its revenue base and reduce dependence on a single product category.

The Internal Auditor periodically reviews business processes and evaluates the adequacy and effectiveness of internal controls. Internal Audit Reports are placed before the Audit Committee for review. The Audit Committee considers the observations and recommendations and monitors corrective actions, wherever required.

The management is of the opinion that the Company's internal control systems are adequate and commensurate with the size and nature of its business and provide reasonable assurance regarding the safeguarding of assets, reliability of financial reporting, operational efficiency and compliance with applicable laws and regulations.

8. DISCUSSION ON FINANCIAL PERFORMANCE WITH RESPECT TO OPERATIONAL PERFORMANCE

The Company's financial performance during the year was influenced by a combination of operational and market-related factors.

Revenue performance was driven by seed demand across different crop categories, seasonal agricultural activities, geographical market penetration, product mix, and prevailing industry conditions.

Profitability was impacted by factors including raw material procurement costs, processing efficiency, logistics expenses, employee costs, inventory management, and overall market conditions.

The Company continued to focus on operational efficiency, cost optimization, quality improvement, and working capital management to strengthen financial performance and enhance shareholder value.

A detailed analysis of financial results is provided in the Board's Report and the audited Financial Statements forming part of the Annual Report.

9. MATERIAL DEVELOPMENTS IN HUMAN RESOURCES

Human resources continue to be a key driver of the Company's long-term success. The Company recognizes that employee competence, commitment, and productivity are critical factors in achieving sustainable growth.

The Company follows a strategy of attracting and retaining the best talent and keep employees engaged, motivated and innovative. The Company continues to have cordial relations with its employees and provide personnel development opportunities for all round exposure to them. As on 31st March, 2026, the Company had 34 employees.

The Company's human resource strategy focuses on:

Reason for changes more than 25% in financial ratio

Inventory Turnover: The Inventory Turnover Ratio decreased from **4.51 times in FY 2024-25** to **3.33 times in FY 2025-26**, representing a decrease of approximately **26.16%**.

The decrease was primarily attributable to a higher level of inventory maintained during the year in anticipation of seasonal demand and to ensure adequate availability of seed products. The increase in inventory levels, relative to the corresponding movement in cost of goods sold, resulted in a lower inventory turnover ratio during the year.

Debt-Equity Ratio: The Debt-Equity Ratio increased from 0.0042 in FY 2024-25 to 0.0112 in FY 2025-26. The increase was primarily due to an increase in borrowings during the year in comparison with the previous year, while the Company's equity base remained relatively stable. Notwithstanding the increase in the ratio, the overall level of financial leverage of the Company remained low.

Operating Profit Margin: The Operating Profit Margin increased from **3.04% in FY 2024-25 to 3.82% in FY 2025-26**, representing an improvement of approximately **25.66%**. The improvement was primarily attributable to better operating efficiency, improved cost management and optimisation of operating expenses during the year. The Company continued to focus on operational efficiencies and effective management of its procurement, processing and other operating costs, which contributed to the improvement in operating margins.

The remaining ratios did not undergo variations exceeding the prescribed threshold requiring specific explanation, except where otherwise disclosed in the Financial Statements.

The Company continuously monitors key financial and operational indicators to ensure effective utilisation of resources and sustainable financial performance.

11. RETURN ON NET WORTH

Return on Net Worth ("RONW") is an important measure of the Company's ability to generate earnings from shareholders' funds.

The RONW of the Company for FY 2025-26 was **6.42%**, as compared with **6.64%** during FY 2024-25.

The marginal reduction in RONW reflects the movement in profitability and shareholders' funds during the year. The Company continues to focus on improving operational performance, efficient capital utilisation and sustainable value creation for its shareholders.

Detailed financial information and relevant calculations are provided in the Financial Statements and Notes forming part of this Annual Report.

4. Committees of the Board

The Company has constituted various Committees for enabling smooth decision-making process in the Company. and the report submitted by the monitoring agency monitoring the utilisation of proceeds of a public issue or rights issue, preferential issue or qualified institutional placement, and making appropriate recommendations to the board to take up steps in this matter;

Notes to Standalone Financial Statements for the year ended 31st March 2026

1.1 CORPORATE INFORMATION

Shreeoswal Seeds and Chemicals Limited ("the Company") was originally registered as a partnership firm as "M/s Oswal Seeds and Chemicals" dated July 29, 2002 which was then converted into public limited company i.e. SHREEOSWAL SEEDS AND CHEMICALS LIMITED having CIN: U01100MP2018PLC045146 vide fresh certificate of incorporation dated December 1, 2017.

The registered office of the Company is situated at Oswal House, Opposite Bal Kavi Bairagi College, Village-Kanawati, Neemuch -458441, Madhya Pradesh, India.

Shreeoswal Seeds and Chemicals Limited ("the Company") is a limited company incorporated in India under the provisions of the Companies Act, 2013. The Company is a Processing unit involved in processing of agriculture seeds along with Trading of Agriculture Produce.

1.2 BASIS OF PREPARATION

COMPLIANCE WITH IND-AS

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards ("Ind AS") as notified by Ministry of Corporate Affairs pursuant to section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016.

CURRENT / NON-CURRENT CLASSIFICATION

All assets and liabilities have been classified and disclosed as current or non-current as per the Company's normal operating cycle and other criteria set out in division II of Schedule III of the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as up to twelve months for the purpose of current or non-current classification of assets and liabilities.

BASIS OF MEASUREMENT

The Company's financial statements have been prepared on a historical cost basis, except for the assets and liabilities that require measurement at fair value in accordance with Ind AS. The financial statements are presented in Indian Rupees and all values are rounded to the nearest lakhs (INR 00,000), except otherwise indicated.

1.3 SUMMARY OF MATERIAL ACCOUNTING POLICIES

a. Key accounting estimates and judgments

The preparation and presentation of financial statements in conformity with Ind AS requires management to make judgments, estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent liabilities on the date of the financial statements and reported amounts of revenues and expenses during the period.

Although these estimates are based on the management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods. Accounting estimates could change from period to period. Any revision to accounting estimates is recognized prospectively in the current and future periods, and if material, their effects are disclosed in the financial statements. Actual results could differ from the estimates. Any difference between the actual results and estimates are recognized in the period in which the results are known/materialize.

Information about critical judgments in applying accounting policies, as well as estimates and assumptions that have the most significant effect to the carrying amounts of assets and liabilities within the next financial year, are included in the following notes:

- I. Measurement of defined benefit obligations
- II. Measurement and likelihood of occurrence of contingencies
- III. Recognition of deferred tax assets

b. Inventories

Inventories are valued at lower of cost and net realizable value (except as otherwise stated) on an item-by-item basis, as under:

Raw materials, packing materials, stores and spares: Cost of inventory comprises all costs of purchase, duties and taxes (other than those subsequently recoverable from tax authorities) and all other costs incurred in bringing the inventories to their present location and condition. Raw materials and other items held for use in the production of inventories are not written down below cost if the finished products in which they will be incorporated are expected to be sold at or above cost. Cost is determined on a first-in first-out formula.

Work-in-progress and finished goods: Cost includes direct materials and costs of conversion in the form of labour and a systematic allocation of fixed and variable production overheads. It also includes other costs which are incurred in bringing the inventories to their present location and condition. The allocation of fixed production overheads is based on normal capacity of production. Cost is determined on first-in first-out formula. The expected scrap value is deducted from the cost to arrive at the net cost of inventories. However, cost of inventories neither includes abnormal amounts of wasted material nor any scrap realizations there from.

By products and scrap are recognized at their net realizable value.

Stock-in-trade: Cost includes cost of purchases, duties and taxes (other than those subsequently recoverable from authorities) and other costs which are incurred in bringing the inventories to their present location and condition. Cost is determined on a first-in first-out formula.

Net realizable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

Cost of agricultural produce is deemed to be the fair value on the date of rise.

Cost of finished goods and work-in-progress include cost of conversion and other costs incurred in bringing the inventories to their present location and condition.

c. Taxes

Current income tax

Current income tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted at the reporting date.

Current income tax relating to items recognized directly in equity is recognized in equity and not in the statement of profit and loss. Management periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate.

Deferred tax

The tax expenses for the period comprise of current tax and deferred tax. The Company exercises judgment in computation of current tax considering the relevant rulings and reassesses the carrying amount of deferred tax assets at the end of each reporting period

d. Property, plant and equipment

Property, plant and equipment are stated at historical cost less accumulated depreciation and impairment losses, if any. Cost comprises of purchase price net of trade discounts and rebates, non-refundable duties

and taxes, any directly attributable cost of bringing the asset to its working condition for its intended use. Cost also includes borrowing cost directly attributable to acquisition / construction of a qualifying asset up to the date the asset is ready for its intended use. Subsequent expenditure on fixed assets is capitalized only if such expenditure results into an increase in the future benefits from such asset beyond its previously assessed standard of performance.

An item of property, plant and equipment and any significant part initially recognized is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is derecognized.

Capital work-in-progress comprises the cost of property, plant and equipment that are yet not ready for their intended use at the balance sheet date. The depreciable amount of a depreciable fixed asset is allocated on a systematic basis to each accounting period over the useful life of the asset. Management's estimate of useful life, which is duly supported by technical evidence, is as stipulated in Schedule II to the Companies Act, 2013. The useful life is for the whole of the asset, except where cost of a part of the asset is significant to total cost of the asset and useful life of that part is different from the useful life of the remaining asset, useful life of that significant part ("component") is determined separately and the depreciable amount of the said component is allocated on a systematic basis to each accounting period during the useful life of the asset.

In arriving at the depreciable amount, residual value in case of certain assets are considered to be more than 5% of the original cost, this estimate of residual value is duly supported by technical advice. Depreciation on assets acquired during the year is calculated on a pro-rata basis from the date of addition. Similarly, depreciation on assets sold, discarded, demolished or destroyed during the year is also calculated on a pro rata basis up to the date on which such asset has been sold, discarded, demolished or destroyed. Depreciable assets costing up to Rupees 1,000/- are depreciated fully in the year of acquisition. The residual values, useful lives and methods of depreciation of property, plant and equipment are reviewed at each financial year end and adjusted prospectively, if appropriate.

e. Leases

IND-AS 116 "Leases" is mandatory for the accounting period commencing on and from 1st April 2019, and has replaced the existing IND-AS 17 relating to leases. We have applied the modified retrospective approach, for which no significant adjustments were required to be made to the retained earnings as at 1st April 2019. However, no material lease has been recognized for the year ending March 31, 2026.

f. Employee benefits

Short term employee benefits

All employee benefits which fall due wholly within twelve months after the end of the period in which employee renders the related service are classified as short-term employee benefits. Undiscounted value of short term benefits such as salaries, wages, bonus and ex-gratia are recognized in the period in which the employee renders the related service.

Defined Contribution Plans:

The Company's Employee's Provident Fund scheme, Employee's State Insurance Scheme and Employee's Superannuation Scheme are defined contribution plans. The Company's contribution payable under the schemes is recognized as an expense in the statement of profit and loss during the period in which the employee renders the related service.

Defined benefit plan Gratuity

The Company operates a defined benefit gratuity plan, which requires contributions to be made to a separately administered fund. The defined benefit plan surplus or deficit on the balance sheet comprises the total for each of the fair value of plan assets less the present value of the defined liabilities. The cost of

providing benefits under the defined benefit plan is determined based on independent actuarial valuation using the projected unit credit method. The gratuity liability is measured at the present value of the estimated future cash flows. The discount rates used for determining the present value of the obligation under defined benefit plan, is based on the market yield on government securities as at the balance sheet date.

Re-measurements, comprising of actuarial gains and losses, the effect of the asset ceiling, excluding amounts included in net interest on the net defined benefit liability and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability), are recognized immediately in the balance sheet with a corresponding debit or credit to retained earnings through OCI in the period in which they occur. Re-measurements are not reclassified to profit or loss in subsequent periods.

Past service costs are recognized in profit or loss on the earlier of:

The date of the plan amendment or curtailment, and

The date that the Group recognizes related restructuring cost

Net interest is calculated by applying the discount rate to the net defined benefit liability or asset.

The Company recognizes the following changes in the net defined benefit obligation as an expense in the statement of profit and loss: Service costs comprising current service costs, past-service costs, gains and losses on curtailments and non-routine settlements; and Net interest expense or income

As per Actuarial Valuations as on 31st March, 2026 and recognised in the financial statements in respect of Employee Benefit Schemes: The liabilities arising in the Defined Benefit Schemes are determined in accordance with the advice of independent, professionally qualified actuaries, using the projected unit credit method as at year end.

g. Earnings Per Share

Earnings per share (EPS) is calculated by dividing the net profit for the year attributable to the equity shareholders by weighted average number of equity shares outstanding during the year. For the purpose of calculating diluted earnings per share, the net profit for the period attributable to equity shareholders and weighted average number of shares outstanding during the period is adjusted for the effects of all diluted potential equity shares.

h. Impairment of non-financial assets

The Company assesses, at each reporting date, whether there is an indication that an asset may be impaired. If any indication exists, or when annual impairment testing for an asset is required, the Company estimates the asset's recoverable amount. An asset's recoverable amount is the higher of an asset's or cash-generating units (CGU) fair value less costs of disposal and its value in use. Recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. When the carrying amount of an asset or CGU exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transactions are taken into account. If no such transactions can be identified, an appropriate valuation model is used. These calculations are corroborated by valuation multiples or other available fair value indicators. No such asset was impaired during the reporting period..

i. Provisions

Provisions are recognized when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. When the

Company expects some or all of a provision to be reimbursed, the reimbursement is recognized as a separate asset, but only when the reimbursement is virtually certain. The expense relating to a provision is presented in the statement of profit and loss net of any reimbursement.

j. Revenue recognition

Revenue is measured at the fair value of consideration received or receivable. Amounts disclosed as revenue are inclusive of excise duty and net of returns, trade discount or rebates. The Company recognizes revenue when the amount of revenue can be reliably measured and it is probable that future economic benefits will flow to the Company.

Revenue from Sale of goods

Revenues from sales of goods are recognized upon transfer of control of promised goods to customer, which are generally on dispatch of goods and the customer has accepted the products in accordance with the agreed terms. There is no continuing managerial involvement with the goods and the Company retains no effective control of goods transferred to a degree usually associated with ownership. Revenue from sales of goods is based on the price quoted in the market or price specified in the sales contracts.

k. Other Income

Other Income is comprised primarily of interest income, discounts and lease rent. Interest income is recognized on accrual basis.

l. Financial Assets

Purchase and sale of Financial Assets are recognised using trade date accounting. Trade receivables that do not contain a significant financing component are measured at transaction price.

The Company has elected to account for its investments in subsidiaries, associates and joint venture at cost less impairment loss (if any). All other equity investments are measured at fair value, with value changes recognised in Statement of Profit and Loss.

For financial guarantee contracts at initial recognition, financial guarantee contracts are measured at fair value, which, in the absence of an active market, is determined based on the present value of future commission income using the Company's incremental borrowing rate. Subsequently, financial guarantee liabilities are measured at the higher of (i) the amount of the loss allowance determined in accordance with the expected credit loss model and (ii) the amount initially recognized less cumulative income recognized under Ind AS 115 – Revenue from Contracts with Customers. The related income is deferred and recognized in the statement of profit and loss over the term of the guarantee using the effective interest method. Financial guarantee receivables are classified and measured at **amortised cost**, as they are held within a business model to collect contractual cash flows that are solely payments of principal and interest.

Classification

The Company classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss), and
- those measured at amortized cost

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit and loss or other comprehensive income.

Derecognition of financial assets

A financial asset is derecognized only when

- The Company has transferred the rights to receive cash flows from the financial asset or

- Retains the contractual rights to receive the cash flows of the financial asset but assumes a contractual obligation to pay cash flows to one or more recipients.

Where the Company has transferred an asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, the financial asset is derecognized. Where the Company has not transferred substantially all risks and rewards of ownership of financial asset, the financial asset is not derecognized.

Where the Company has neither transferred a financial asset nor retains substantially all risks and rewards of ownership of the financial asset, the financial asset is derecognized if the Company has not retained control of the financial asset. Where the Company retains control of the financial asset, the asset is continued to be recognized to the extent of continuing involvement in the financial asset.

m. Borrowings

After initial recognition, interest bearing loans and borrowings are subsequently measured at amortized cost using the effective interest rate method. Gains and losses are recognized in profit or loss when the liabilities are derecognized as well as the effective interest rate amortization process.

Amortized cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortization is included as finance cost in the statement of profit and loss.

n. Cash and Cash Equivalents

Cash and cash equivalents comprise of cash on hand, cash at banks, short-term deposits and short-term highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

o. Litigations

The nature of business of the company is agro based commodities and legal pending cases against the company at district court are due to Non-Germination of Agro Seeds or failure of Seeds Sample and which may be happened by any of the one condition i.e. Climate changes, Soil Issue, excess or less water used while irrigation of crop, Non-Germination and farmer negligence which is not the fault of the company. Further quantum of the amount is not ascertainable and nature of the cases are in criminal hence there was no impact on financial of the Company.

p. Financial Liabilities

For trade and other payables maturing within one year from the balance sheet date, the carrying amounts are determined to approximate fair value due to the short maturity of these instruments.

q. Offsetting

Financial Assets and Financial Liabilities are offset and the net amount is presented in the balance sheet when, and only when, the Company has a legally enforceable right to set off the amount and it intends, either to settle them on a net basis or to realize the asset and settle the liability simultaneously.

r. Contingent Liabilities

Disclosure of contingent liability is made when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources embodying economic benefits will be required to settle or a reliable estimate of amount cannot be made.

s. Provisions

The timing of recognition and quantification of the liability (including litigations) requires the application of judgement to existing facts and circumstances, which can be subject to change. The carrying amounts of provisions and liabilities are reviewed regularly and revised to take account of changing facts and circumstances.

Note No:40 Financial Risk Management

(i) Credit Risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations. Credit risk primarily relates to trade and other receivables, long-term loans, cash and cash equivalents.

The Company's exposure to credit risk with regards to trade and other receivables is influenced mainly by the individual characteristics of each customer and there is no significant concentration of risk related to industry segments. The granting of credit is controlled by well-established criteria that are reviewed on a regular basis. The maximum exposure to credit risk at the reporting date is the carrying amount of each trade receivable.

The credit policy requires each new customer to be analyzed individually for credit worthiness before delivery and payment terms are offered.

Other receivables consist primarily of security deposits, loans to employees and other receivables. The risk of default is assessed as low.

The credit risk surrounding loans receivable is assessed as low risk.

Credit risk on cash and cash equivalents is assessed as low risk as the Company deposits cash surpluses with financial institutions of high quality and standing.

(ii) Liquidity Risk

The Company actively monitors its cash flows to ensure there is sufficient cash available to meet its working capital requirements. Due to the dynamic nature of the underlying businesses, the Company maintains flexibility in funding by maintaining availability under committed credit lines. Management monitors rolling forecasts of the Company's cash and cash equivalents on the basis of expected cash flow.

The Company's current trade and other payables are all due within one year.

1.1 CORPORATE INFORMATION

The consolidated financial statements comprise of financial statements of “Shreeoswal Seeds and Chemicals Limited” (The Holding Company” or “The Company”) and its subsidiaries (Collectively referred to as “the Group”) for the year ended 31st March, 2026.

The Holding Company was originally registered as a partnership firm as “M/s Oswal Seeds and Chemicals” dated July 29, 2002 which was then converted into public limited company i.e. Shreeoswal Seeds And Chemicals Limited having CIN: U01100MP2018PLC045146 vide fresh certificate of incorporation dated December 1, 2017. The registered office of the Company is situated at Oswal House, Opposite BalkaviBairagi College, Village-Kanawati, Neemuch -458441, Madhya Pradesh, India.

The principal activities of the group consist of activities spanning across processing of Seed, trading of agriculture produce, production and trade of psyllium husk. Further details of about the business operations of the group are provided in Note No. 39 : Segment Information.

1.2 BASIS OF PREPARATION

COMPLIANCE WITH IND-AS

The Consolidated financial statements of the Company have been prepared in accordance with Indian Accounting Standards (“Ind AS”) as notified by Ministry of Corporate Affairs pursuant to section 133 of the Companies Act, 2013 read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Amendment Rules, 2016 as applicable on the consolidated financial statements.

The consolidated financial statement has been prepared on the historical cost basis except for the following assets and liabilities which have been measured at fair value amount:

- a. Certain financial assets and liabilities
- b. Defined benefit plan's - plan asset

The Consolidated Financial Statements comprises of Shreeoswal Seeds and Chemicals Limited and all its subsidiaries, being the entities that it controls. Control is assessed in accordance with the requirement of Ind AS 110 – Consolidated Financial Statements

The financial statements have been prepared on accrual and going concern basis. The accounting policies are applied consistently to all the periods presented in the financial statements.

CURRENT / NON-CURRENT CLASSIFICATION

All assets and liabilities have been classified and disclosed as current or non-current as per the Company's normal operating cycle and other criteria set out in division II of Schedule III of the Companies Act, 2013. Based on the nature of products and the time between the acquisition of assets for processing and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as up to twelve months for the purpose of current or non-current classification of assets and liabilities.

BASIS OF MEASUREMENT

The financial statements have been prepared on a historical cost basis, except for the assets and liabilities that require measurement at fair value in accordance with Ind AS. The financial statements are presented in Indian Rupees and all values are rounded to the nearest lakhs (INR 00,000), except otherwise indicated.

1.3 PRINCIPLES OF CONSOLIDATION

The consolidated financial statements relate to Simran Farms Limited (“the company”) and its subsidiary company. The consolidated financial statements have been prepared on the following basis:

- a. The financial statements of the company and its subsidiaries are combined on a line by line basis by adding together like terms of assets, liabilities, equity,. Incomes, expenses, and cash flows, after fully eliminating intra-group balances and intra- group transactions.
- b. Profits or losses resulting from intra-group transactions that are recognised in assets, such as inventory and property, plant & equipment, are eliminated full.
- c. Offset (eliminate) the carrying amount of the parent’s investment in each subsidiary and the parent’s portion of equity of each subsidiary.
- d. Non controlling interest’s share of profit/loss of consolidated subsidiaries for the year is identified and adjusted against the income of the group in order to arrive at the net income attributable to shareholders of the company.

These are set out under “Significant Accounting Policies” as given in the Company’s standalone financial statements.

In consideration of guarantee company has received annual (full or part) fees of Rs. 22.00 Lakhs. The fair value of the financial guarantee at inception was determined to be ₹131.90 lakhs, based on the present value of expected future commission income using a discount rate of 9% p.a.. The income from the guarantee is recognized over the tenure of the guarantee in accordance with Ind AS 115 using EIR method. As at March 31, 2026, the carrying value of these guarantees is Rs.93.19 lacs. The liability reflects the higher of expected credit losses and the unamortized initial fair value, as per Ind AS 109. The maximum exposure to credit risk under these guarantees is Rs.220.00 crores (Excluding the value of primary security of Rs. 161.38 crores and collateral security of Rs.56.00 crores against which loan is obtained by borrower). However possibility of recovery from the company is negligible as there is sufficient primar and collateral security provided by the borrower. hence no provision made for the contingent liability

Note No: 40 Financial Risk Management

(i) Credit Risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations. Credit risk primarily relates to trade and other receivables, long-term loans, cash and cash equivalents.

The Company's exposure to credit risk with regards to trade and other receivables is influenced mainly by the individual characteristics of each customer and there is no significant concentration of risk related to industry segments. The granting of credit is controlled by well-established criteria that are reviewed on a regular basis. The maximum exposure to credit risk at the reporting date is the carrying amount of each trade receivable.

The credit policy requires each new customer to be analyzed individually for credit worthiness before delivery and payment terms are offered.

Other receivables consist primarily of security deposits, loans to employees and other receivables. The risk of default is assessed as low.

The credit risk surrounding loans receivable is assessed as low risk.

Credit risk on cash and cash equivalents is assessed as low risk as the Company deposits cash surpluses with financial institutions of high quality and standing.

(ii) Liquidity Risk

The Company actively monitors its cash flows to ensure there is sufficient cash available to meet its working capital requirements. Due to the dynamic nature of the underlying businesses, the Company maintains flexibility in funding by maintaining availability under committed credit lines. Management monitors rolling forecasts of the Company's cash and cash equivalents on the basis of expected cash flow.

The Company's current trade and other payables are all due within one year.
