#### IT IS MY TURN...

Soon after meeting Kharge, Siddaramaiah drove down to the residence of KC Venugopal, the AICC general secretary in charge of Karnataka.

In all this drama, the Gandhi family took a back seat and left the entire matter to Kharge for two reasons: He hails from Karnataka and knows all the players like the back of his hand and, secondly, they did not want to give the impression that there is a high command over and above the AICC chief. Privately, DKS has said he will do whatever Sonia Gandhi says. "She wanted me to deliver Karnataka and that is what I did. I am a loyalist and willing to go with the party." Kharge earlier in the day also held discussion with former party chief Rahul Gandhi, who drove down to his residence. AICC general secretary K C Venugopal also held a separate meeting with Gandhi to discuss the issue of government formation in Karnataka. FRESH CLAIMANTS: Meanwhile, former deputy CM and senior party leader G Parmeshwara Tuesday sprang a surprise stating that he was ready to take up the responsibility if the party high command asked him to do so. "If the high command wants, I am ready to take up the responsibility," the former Deputy Chief Minister told reporters, adding that a Dalit leader should become the chief minister.

He further said that the high command was aware of his service to the party, and he doesn't feel the need to lobby for the post. "I trusted the party leaders. I can form a group of 50 MLAs. But I don't do that. I have some principles. Discipline is important to me. If the high command gives me the responsibility of CM, I will definitely do it. Also, I have served as the Deputy Chief Minister. The High Command knows everything about me and my work, so I don't want to lobby. That doesn't mean I'm incapable; I'm capable and if given an opportunity will do the job," Parmeshwara said.

Another fresh claim has cropped up from Bengaluru. The All India Veershaiva Mahasabha, which represents the influential Lingayat community, has bid for the top post, citing that 34 of the newly elected Congress MLAs are Lingayats. The swing of the Lingayat vote, once a key support base of the BJP, has been identified as a key factor in the Congress win this time. In a letter addressed to Kharge, the All India Veerashaiva Mahasabha has said that the Congress had fielded 46 candidates from the community and 34 of them won. 'Furthermore, we wish to bring to your kind notice that our community has played a major role in electing other smaller communities in other 50 constituencies. This shows that the traditional voter of the BJP has shifted its loyalty to the Congress party, thereby supporting the Congress party to win 134 constituencies in the state,' the letter adds. "Considering the above facts, we now urge the Congress party to give a chance/consider a Veerashaiva Lingayat community leader for the post of Chief Minister of Karnataka state," the letter stated. According to AICC spokesperson Pawan Khera, a decision on the appointment of the Chief Minister of Karnataka will be taken by tomorrow.

#### Monsoon to hit...

Rainfed agriculture is a critical component of India's agricultural landscape, with 52 per cent of the net cultivated area relying on this method. It accounts for about 40 per cent of the country's total food production, making it a crucial contributor to India's food security and economic stability.

The IMD has not announced the onset of monsoon in other parts of the country. This year, Punjab, Haryana, Delhi, Rajasthan, Uttar Pradesh, Himachal Pradesh, Jammu and Kashmir, Ladakh and Uttarakhand have received 18 per cent excess rainfall in the pre-monsoon season so far, according to IMD data.

"There is no one-to-one relationship between the onset date and the total rainfall over the country during the season. Also, the monsoon arriving early or late in Kerala doesn't mean it will cover other parts of the country accordingly. The monsoon is characterised by largescale variables and global, regional and local features,' IMD chief M Mohapatra told PTI.

#### Amnesty: No Army...

The chaos unleashed by Imran's supporters against State institutions and military installations has been linked to the former premier's anti-military stance, open accusation and naming and shaming of senior serving military officials for being behind attempts on his life. Now, with the Army resolved to respond to this narrative with legal cases, Imran Khan's coming days may just be numbered and he may be booked and put on trial under the same references. If a case is lodged against Imran Khan and he is put to trial under any of the Army Acts, he may face life imprisonment or capital punishment. Meanwhile, the Lahore High Court on Tuesday reserved the verdict on Khan's petition seeking bail in all cases registered against him in Punjab province following his arrest in a corruption case last week that sparked violent protests by his supporters.

#### Cong reality check...

The Gruha Jyothi scheme has come under the scanner for financial implications. The Congress claimed the scheme will cost Rs7,000 crore a year, but experts say that there are 1.9 crore households in the state and if 200 units are given free per month, the consumption will be 3,845 million units a month. This translates to Rs44,404 crore. Even if half the households were to get free power, the amount required would be around Rs20,000 crore a year. The scheme is now likely to be extended only to those who use 200 or less units of power in a month. "The offer will not be extended to those who use one unit more (201 units)," said a senior Congress leader, echoing the Delhi model of the Aam Aadmi Party government there. Another poll promise being tweaked is about women being able to travel free of charge in government buses anywhere in Karnataka.

The free ride will be restricted to the daily commuter's route in an ordinary bus and will not apply to rides on semi-deluxe or deluxe buses. For instance, it will be provided between home and office and not across the city or the state. "If we allow free travel for all women, the already-bleeding transport corporations may face more losses," a senior transport officer was quoted in the media as saying. The 10kg free rice for BPL families (Anna Bhagya), Rs3,000 every month for graduate youth and Rs1,500 for diploma-holders (both in the age group of 18-25) for two years (YuvaNidhi) will also come with several riders. The freebies will entail a cost of about Rs40,000 crore annually, which is 15% of the state budget, a senior Congress leader was quoted in the media as saying. Hence, the new government cannot afford to

मृतक बालक पायल को बहुत खटकता था जो उसे उसके घर उपर आना भी पंसद नही था। इसी दौरान आरोपी की तीसरी पत्नी पायल को तीन माह पर्व मायके में एक पुत्र की प्राप्ति हुई तब से आरोपिया
